Bulls were weighed on test Dec. 17 after a 14-day warm-up period. They averaged 752 lb. going on test.

At the 28-day mark, the bulls were averaging 2.02 lb. ADG and 2.24 lb. WDA, weighing an average of 809 lb.

Additional interim weights will be collected Feb. 11, March 10, April 7 and May 5. The bulls will be weighed off test June 2. Qualifying bulls will sell Oct. 10.

Joining the 36-year-old bull test is a new heifer development program that is utilizing the latest in precision ag livestock technology combined with genomic testing to develop a group of heifers that will have more data and information collected on them than any other program in the Southeast, say program coordinators.
