changed due to the new technology. There are now three separate contemporary groups (A, B and C), vs. one complete test group as in years past. Instead of 38 individual pens, the test facility now has two large pens and 10 individual pens. Bulls in the large pens are the RFI-tested bulls. Because of age, management and time of year, it seemed appropriate to break out the 147 bulls currently on test into three separate contemporary groups.

Group A includes older bulls born between Jan. 1-Feb. 28, 2015. They were placed in the RFI testing pen to measure intake for the first 60 days of the test. Group B consists of the younger calves scheduled to be RFI tested during the last 60 days of the overall test. These calves are in a similar sized pen as Group A; however, they are a bit lighter due to being 60 days younger. Group C is considered the individually tested bulls. These bulls are penned in groups of two to four head per pen. The management of these bulls is similar to years past, with calves penned separately by owner. This group has some of the largest bulls on test.
